Craig Allen is organizing four sessions at The Eastern Economic Association meetings which will be held in Washington DC February 26-28, 2016.


#### **Upcoming Meetings**

#### Minutes of the Summer Board of Director's Meeting July 25-26, 2015 Chicago, IL

- 1. Lawrence Spizman called the meeting to order at 8:02 AM. Larry thanked everyone for traveling to Chicago and noted that Kurt Krueger had to miss the meeting last minute to deal with a family issue.
- Marc Weinstein outlined the schedule for the weekend for the Board of Directors ("BOD"). A copy of the BOD schedule is attached as Exhibit A to these minutes.
- Marc Weinstein presented the meeting minutes from the BOD meeting in Boston, MA in January 2015.
  - It was moved and seconded (Rosenbaum, MacPherson) that the Board approves the minutes of the Board of Directors' meeting of January 3, 2015 (Vote: 7 Yes - 0 No - 0 Abstain). These minutes are attached as Exhibit B to these minutes.
- Marc Weinstein presented the meeting minutes from an online meeting held on January 20, 2015.
  - It was moved and seconded (Rosenbaum, MacPherson) that the Board approves the minutes of the Board of Directors' electronic meeting of January 20, 2015 (Vote: 7 Yes - 0 No - 0 Abstain). These minutes are attached as Exhibit C to these
- Marc Weinstein presented the meeting minutes from an online meeting held on April 16, 2015.
  - It was moved and seconded (Cahill, Adams) that the Board approves the minutes of the Board of Directors' electronic meeting of April 16, 2015 (Vote: 7 Yes - 0 No - 0 Abstain). These minutes are attached as Exhibit D to these minutes.
- Marc Weinstein presented the Executive Director reports which included the Financial Statements for the six months ended May, 31, 2015 and 2014 completed by the Block Teitelman Group, a Membership Report, and current bank statements.
  - Various discussions were held with respect to the financial statements by NAFE's new accountant and how professional they looked. Kevin Cahill questioned the publication expense which was explained by Steve Shapiro regarding a printing error with the JFE and Kevin also inquired about a lost check on the register which Marc Weinstein explained it was a voided check.
    - It was moved and seconded (Brandt, Allen) that the Board accepts the financial statements ending May 31, 2015 and the membership report, as presented. (Vote: 7 Yes - 0 No - 0 Abstain). These reports are attached collectively as Exhibit E to these minutes.
- Kevin Cahill presented the plan for the NAFE sessions at the ASSA in San Francisco, CA in January 2016. NAFE will hold four sessions at the ASSA, one on Sunday January 3 and three on Monday January 4, 2016. The BOD meeting will be held Sunday January 3 starting at 11:00 AM followed by one session at 2:30 PM. Following the 2:30 PM session, NAFE will hold their annual Membership Meeting followed by our cocktail reception celebrating our 30<sup>th</sup> Year Anniversary. The three sessions on Monday January 4, 2016 will be at 8:00 AM, 10:15 AM, and 2:30 PM. The following logo was developed for the 30-year anniversary.



- 8. David Rosenblum indicated that NAFE will hold one session at the Missouri Valley Economic Association ("MVEA") on Friday October 23, 2015 and as with past years, will sponsor a cocktail reception by donating \$500 to the MVEA.
- Frank Adams noted that NAFE will hold one or two sessions at the Southern Economic Association ("SEA") meetings in New Orleans, Louisiana on Saturday November 21, 2015. There will most likely be one paper session and one panel session.
- 10. Craig Allen summarized the NAFE sessions at the Eastern Economic Association ("EEA") annual meeting were held at the Sheraton Times Square in New York on February 27-28, 2015. There was a securities session by members of the National Economic Research Associates ("NERA") and several newer NAFE members participated. Matt McCabe presented a paper after recovering over the past couple years from a heart transplant. Approximately 40 members attended the sessions.
  - Craig reported that the NAFE sessions at the EEA will be on February 26-27, 2016 in Washington, DC at the Marriott Wardman Park. The traditional model will be followed where there is one session on Friday late afternoon followed by three sessions on Saturday. Craig reported that there will be one entire session devoted to Real Estate and other issues in Forensic Economics.
- 11. Bill Brandt rehashed the NAFE Sessions at the Western Economic Association International ("WEAI") which were held on June 29-30, 2015 at the Hilton Hawaiian Village in Honolulu, HI. There were 11 papers presented over 5 sessions and a cocktail reception at the Fresco Italian Restaurant. Bill noted that the WEAI attendance was strong but NAFE's participation was down from prior
  - Bill announced that the WEAI in 2016 will be held on Portland, Oregon from June 29 through July 3, 2016. NAFE Will hold sessions over two dates and the current thought is July 1 and 2, 2016. More concrete plans will be announced at a later time. (continued)

- 12. Steve Shapiro announced that the NAFE winter meeting is typically the weekend before the Super Bowl each year and was held in Puerto Rico in 2015. Steve mentioned that the next NAFE Winter meeting will be held in Key West, Florida on January 29-30, 2016 and will be organized by Art Eubank and David Schap.
- 13. Steve Shapiro discussed the NAFE International meeting which was held in Amsterdam, Netherlands on May 23, 2015 and attended by 14 people which included two members from Italy. Steve also indicated that the 2016 NAFE International meeting will be held in Bucharest, Romania on May 23, 2016 and is being organized by Jack Ward.
- 14. In Kurt Krueger's absence, Kevin Cahill presented the report of the Nominating Committee which consisted of Krueger (Chair), Cahill, Jim Rodgers (the Past President representative) and Michael Soudry. Frank Adam's term as Southern Vice President ("VP") and Kevin Cahills term of At-Large VP will expire at the conclusion of the Membership Meeting in San Francisco, CA on January 3, 2016. Additionally, the committee was charged with recommending a President-Elect to replace Larry Spizman at the conclusion of the Membership Meeting in January 2017. The committee recommended the following members for each position:

- F, It was moved and seconded (MacPherson, Rosenbaum) that the Board accepts the recommendation of the Nominating Committee of Scott Gilbert for At-Large Vice President to serve a three-year term from the end of the Membership Meeting on January 3, 2016 (Vote: 7 Yes 0 No 0 Abstain). Scott's CV is attached as Exhibit G to these minutes.
- G. It was moved and seconded (MacPherson, Rosenbaum) that the Board accepts the recommendation of the Nominating Committee of Gil Mathis for Southern Vice President to serve a three-year term from the end of the Membership Meeting on January 3, 2016 (Vote: 7 Yes 0 No 0 Abstain). David's CV is attached as <u>Exhibit H</u> to these minutes.
- 15. Marc Weinstein presented the proposed United States "Return of Organization Exempt Form Income Tax," Form 990 for the National Association of Forensic Economics for the year 2014. After a brief discussion on why it's recorded that the Board members volunteer 0.0 hours on the form, Marc noted that he would inquiry to Robert Block, CPA why the form is filled in this way.
  - H. It was moved and seconded (Adams, Brandt) that the Board authorizes Marc Weinstein to sign IRS Form 990 for the year 2014 on behalf of NAFE to be filed by the Block Teitelman Group on or before August 17, 2015. (Vote: 7 Yes 0 No 0 Abstain). IRS Form 990 is attached as Exhibit I to these minutes.
- 16. A lengthy discussion regarding the NAFE Newsletter was led by Lane Hudgins, who was recently appointed Editor of the NAFE News and charged with producing the newsletter effective with the first issue in 2016. Lane displayed various other organization's newsletters and explained what NAFE utilized to produce our current newsletter and what appears to be standard in the industry. It was evident from Lane's presentation that our newsletter was rather primitive and changes for the betterment of the organization were warranted. Lane reviewed three quotes she received to update and produce our newsletter in February, May, August, and November, consist with the current timetable. Lane explained the two software alternatives, Publisher and InDesign and their various costs. After the Board thoroughly reviewed the options and weighed the costs, it was agreed that updating and rebranding the newsletter was warranted. Lane announced that the new newsletter will be known as The Forecast and her first issue will be Volume 30, Issue 1 in conjunction with NAFE's 30<sup>th</sup> Year Anniversary in 2016. An additional discussion was held to re-examine producing the newsletter in electronic form only at some point in the future (Summer BOD Meeting 2017) after the newsletter has been produced several times so the members could see and feel The Forecast. Lane will present her Newsletter report at the Membership Meeting on January 3, 2016.
  - It was moved and seconded (Rosenbaum, Macpherson) that the Board authorizes Lane Hudgins to proceed with updating and redesigning the NAFE Newsletter. The Board also authorizes the following expenditures associated with updating the newsletter:
    - Up to \$720 for a one-time template design;
    - b. Up to \$2,400 per annum for newsletter typesetting; and
    - Up to \$3,500 per annum for printing costs.
- 17. Steve Shapiro presented his report on the Journal of Forensic Economics ("JFE"). He indicated that the current issue being produced is 12/2014. There were issues with the new typesetting which caused delays in production of the April 2014 issue; and NAFE incurred additional costs and was previously discussed. Steve indicated that from June 2014 through June 2015, there were 16 original submissions and seven revised submissions amounting to 23 total submissions during this time. Steve further reported that the Editors accepted six, rejected eight, and one was withdrawn. Five papers were out for review, two were out for revision, and one was under editor review. A brief discussion was held on what was rejected and Steve noted that accepted articles are published on the JFE website prior to the issues being printed and mailed. Attached as <a href="Exhibit J">Exhibit J</a> to these minutes is a chart of the activity for the period.

Steve presented the State Paper Series as of January 3, 2014. The Editors are encouraging authors to submit state papers beyond the 32 that have already been published and to at least contact Jim Rodgers or Bob Male if you plan on a certain state. Steve discussed a special issue JFE of updates to states but Jim Rodgers indicated to Steve that it was not worth it at this point. If a State needed an updated paper, any author would be encouraged to contact the editors prior to initiating their work. Cara Brown did inquire about producing a paper about Alberta, Canada

It was announced that over the past year, seven NAFE members opted to receive the JFE in electronic form only. It was noted that dues are not adjusted if you opt out of receiving the paper journal.

## **NAFE Meeting and Finances**

Steve noted that new academic authors could be obtained if the JFE was indexed in REPEC.org. Victor Matheson pushed Allen Press to get the JFE into REPEC and Allen Press was to submit a quote for this endeavor.

Steve informed the Board that the JFE Editors would be revisiting the Journal's Board of Editors and that they hoped to define roles and duties of those individuals.

Jim Ciecka discussed the typesetting to improve the look and quality of the tables presented in the JFE and noted that it was a time -consuming process. Jim noted that Nancy spends a great deal of time performing this task for the organization and since it has been several years, Jim requested that the Board grant Nancy a raise for her continued great work to the organization.

It was moved and seconded (Brandt, Cahill) that the Board grant Nancy Eldredge a \$3,000 raise in recognition of her hard work and many years of excellent service to the organization (Vote: 7 Yes – 0 No – 0 Abstain).

- 18. Steve Shapiro discussed the work and progress of the NAFE Software Committee which is being Chaired by Kristin Kucsma. The members of the committee included Craig Allen, Patrick Anderson, Constantine Boukidis, Kristena Gaylor, Kurt Krueger, Kevin People and Steve Shapiro. The committee agreed that there is a need to define was is "canned software" and had sought member input via the NAFE-L on July 13, 2015. Any member who would like to comment had until September 10, 2015. Craig Allen discussed what he believed was transparent vs. non-transparent software (i.e. retail software) and some of the committee progress. At the time of the Summer BOD meeting, the Board decided to allow the committee to continue their work and no action would be taken at this time. The Board indicated that this issue will be revisited at the January 3, 2016 BOD Meeting, or sooner, if a motion was presented to be included on the NAFE officer ballet. Such a motion would need to be submitted on or before October 1, 2015.
- 19. Marc Weinstein introduced an email presented by Victor Matheson which Victor believed that Forensic Economics should have their own JEL Code dedicated via the American Economic Association ("AEA"). Currently, Forensic Economics is a subset of K1, Basic Areas of Law and shares a the more specific subset K13 with Tort Law and Product Liability. Victor believed that Forensic Economics could have K5 with specific subsets covering the various aspects of Forensic Economics. Larry Spizman discussed that he would champion the issue and lobby the AEA to get Forensic Economics their own code. He would obviously seek assistance from Victor and hoped to report some progress at the Winter BOD Meeting in January 2016.
- 20. Marc Weinstein and Larry Spizman indicated that it appeared to be ideal for the Board to meet next Summer in Chicago again, and that this weekend, the third weekend in July always seemed to be the most convenient for the Board Members. While not officially announced, and since most agreed, it was implied that the NAFE BOD Summer Meeting would be held in Chicago, IL either the third or fourth weekend of July 2016, pending additional discussions.

Since no additional business currently existed, it was moved and seconded (Macpherson, Rosenbaum) to adjourn the Sum mer BOD Meeting (Vote: 7 Yes – 0 No – 0 Abstain).
